- 第一條 依據國立中興大學特聘教授設置辦法第四條及國立中興大學優聘教師彈性薪資獎勵辦法第四條，訂定本辦法。
- 第二條 特聘教授申請者須符合國立中興大學特聘教授設置辦法相關規定，優聘教師申請者須符合國立中興大學優聘教師彈性薪資獎勵辦法相關規定。
- 第三條 特聘教授暨優聘教師申請者，應經系所辦理資格審查，合格申請者之推薦名單、相關證明文件及資料彙整表(如附表一)，由系所再提送至本院特聘教授暨優聘教師遴選審議委員會審查決定推薦名單後送至人事室彙辦。
本院特聘教授暨優聘教師遴選審議委員會五人，任期為一年。其組成方式如下：
一、院長為當然委員兼召集人及會議主席。
二、其餘委員由本院各系所推薦相當於本校講座、特聘教授資格之校外傑出學者專家三人，彙整後之名單再由院長簽請校長核聘四人擔任之，並酌列候補委員數人。
三、本委員會應有委員三分之二以上出席始得開會，並應有出席委員過半數同意始得決議。
四、院長如為特聘教授人選時，應就相關案件全程迴避，且於投票時不列入應出席人數之計算，並由實際參與審議之委員中互選一人擔任主席。
- 第四條 本辦法如有未盡事宜，悉依國立中興大學特聘教授設置辦法及國立中興大學優聘教師彈性薪資獎勵辦法辦理。
- 第五條 本辦法經院務會議通過，報請校長核定後實施，修正時亦同。

Regulations for the Selection of Distinguished Professors and Faculty Members

Amended by the College Affairs Meeting on March 29, 2022 (Article 3)

- Article 1 The Regulations are formulated in accordance with Article 4 of the NCHU *Regulations for the Establishment of Distinguished Professorships* and Article 4 of the NCHU *Regulation Governing Flexible Pay for Distinguished Faculty Members*.
- Article 2 Eligible applicants must be full-time professors, associate professors, or assistant professors at NCHU who meet the criteria specified in either the NCHU *Regulations for the Establishment of Distinguished Professorships* or the NCHU *Regulation Governing Flexible Pay for Distinguished Faculty Members*.
- Article 3 Academic units shall evaluate applicants' eligibility, supporting documents, and the data summary table (Appendix 1). The list of recommended candidates shall then be submitted to the College Committee for further consideration.
- The College Distinguished Professor and Faculty Selection and Appointment Review Committee, composed of five members, shall serve a term of one year. The members are as follows:
1. The Dean shall serve as an ex-officio member, convener, and chairperson of the committee.
 2. Each academic unit shall recommend three non-NCHU scholars/experts who meet the criteria for a chair or distinguished professorship at NCHU. From the resulting shortlist, the President shall appoint four members and designate alternate members as needed.
 3. The meeting quorum shall consist of at least two-thirds of the members, and resolutions shall require the consent of more than half of those present.
 4. If the Dean applies for the distinguished professorship, they must fully recuse themselves from discussions and voting on the matter. They shall not be included in the attendance count, and a chairperson shall be selected from among the committee members participating in the discussion.
- Article 4 Matters not addressed herein shall be governed by the NCHU *Regulations for the Establishment of Distinguished Professorships* and the NCHU *Regulation Governing Flexible Pay for Distinguished Faculty Members*.
- Article 5 The Regulations shall be implemented upon approval by the College Affairs Meeting and the President. Any amendments shall follow the same procedure.
